

What are China Customs regulations?

China customs regulations let you know what items you are not allowed to bring in or out of China, and the things you must declare and pay duty on. If you find you are carrying any of the following you must declare them, according to Chinese Law. They will probably be confiscated and an investigation held.

What happens if a traveler fails to declare items to customs?

Travelers who fail to declare items to the customs authorities -- and bring in prohibited/restricted,or taxable goods or articles -- are penalized accordance with the Customs Law of the People's Republic of China and Regulation of the People's Republic of China on the Implementation of Customs Administrative Punishment. 4.

Can a foreigner bring in duty-free items in China?

Those resident in China may bring in duty-free articles for personal use worth up to a total of RMB 5,000. Customs shall levy duty (20%) on the portion of the article (s) whose value exceeds the duty-free limit. Non-resident visitors may bring in duty-free items, which will remain in China, with a total worth of RMB 2,000.

What items are exempt from customs duties?

The general rule is that items with a total value of up to 5,000 yuan(US\$700.84) are exempt from customs duties. Here are specific details for common items: Gold and Silver: Limited to 50 grams per person. Anything above this requires documentation and must be declared.
