### What is Jamaica customs agency?

Jamaica Customs Agency is one of the major revenue-generating entities of the Jamaican government, accounting for almost 40 percent of taxes. Still, the government has committed to gradually reducing duties, some as high as 180 percent compounded.

#### How do I import meat in Jamaica?

Items are added and taken off as the Government dictates. Persons who wish to import meat products for personal use must have: Meat inspection certificate from the relevant approved official Government Veterinary Division or Ministry of Agriculture. An import licensefrom the Ministry of Agriculture in Jamaica.

#### Does Jamaica have a common external tariff (CET)?

As a CARICOM member state, Jamaica can apply a Common External Tariff (CET) to imports from countries outside CARICOM. The CET typically ranges between 10 - 20 percent. To look up duties and tariffs use, use the Customs Info Database tariff look-up tool, available on trade.gov (free registration required), to estimate duties and taxes.

#### How do I get an import license in Jamaica?

An import license from the Ministry of Agriculturein Jamaica. The Jamaica Tourist Board will make arrangements to obtain the license, if given two weeks' notice. Goods not in compliance with these stipulations will be confiscated and handed over to the relevant authority when detected.
